 - Uniforms – all participants must wear shin guards and socks must completely cover the shin guards
 - Absolutely no jewelry is permitted – medical alert bracelets must be worn inside the uniform and taped
 - Toe cleats are not permitted on the footwear.
 - Goal Keepers are permitted to wear soft billed caps.
- If a referee does not show for a match, the teams can elect to play a scrimmage, but the game is not to be rescheduled and the score is to be reported as a 0 to 0 tie.
- The next sportsmanship classes is scheduled for September 3rd at 7PM. Let Bobby know by Lafor day if you plan on attending.
- Bobby announced that no coaches received red cards in the Spring 2008 season
 - 5 red cards were issued – 4 to players and 1 to a parent
