Meeting Minutes

October 22, 2008

Next meeting: February 17, 2008, 7:30PM, Myersville Elementary School

- Meeting was called to order by Kathryn @7:35.
- Frederick YMCA petition was added to the agenda
- Bobby reported that 7 ejections occurred the previous weekend – all were parents
- Judiciary Committee recommended that parents take the sportsmanship clinic
 - Discussion ensued
 - Suggestions on how to handle the parents and keep this control within each area
 - Discussion transitioned to how to control parents on the field
 - Judiciary committee is to bring three or more options for controlling sportsmanship to a future meeting.
- Judiciary committee recommended a penalty of \$250.00 for each infraction from the registration deadline.
 - HSC put forth a motion to implement the judiciary committees recommendation
 - USA amended the motion to read if the registration is modified after the deadline, a penalty of \$250 per team will be assessed.
 - Motion passed 17 yes, 3 no
- Blow-out scores were discussed – USA was having difficulty assigning power ratings
 - Coaches are not controlling the matches
 - Can the league adopt a rule similar to little league (mercy rule)
 - Discussion ensued
 - USA put forth a motion – as soon as there is a score differential of 5 goals, the team must pull a player. With a differential of 7 goals, a second player must be pulled. Players can reenter the match once the differential reduces below these thresholds
 - Motion passed 15 yes, 5 no
- The Frederick YMCA representative approached the league to affiliate and place 1 or 2 U10 teams into the league
 - Home fields are available at the YMCA
 - No opposition was voiced, FYMCA will become an affiliate member
- Meeting was adjourned
