- Meeting was called to order by Kathryn @7:35.
- DC United representative spoke about continued league support.
- Washington Freedom representative spoke about their league and upcoming matches/schedule.
- WMSOA (Mike Truax) spoke about referee assigning:
 - Youth should look like soccer players
 - Reiterated that NO JEWELRY is permitted
 - WMSOA has approximately 250 referees – 50 are brand new, 40 have one season completed
 - They are continuing to work on the mentoring program
 - Very important to provide referee feedback, both positive and negative on the score reporting matrix for your organization.
 - Toe cleats are not permitted
- The last sportsmanship class for the Spring season will be held this coming Saturday, 28, March.
- Red cards- both coaches and A/C's must e-mail Bobby the day the card is issued.
 - The offending player must show up at the next scheduled match and notify the opposing coach and take a seat on the bench
 - The offending coach must show up at the next scheduled match, check-in with the referee and then proceed to the spectators side of the field
- Bobby reiterated that there is a maximum of three coaches permitted on the sideline and they all must have their sportsmanship cards.
- Reminder that only the A/C can postpone matches based on the field conditions and weather.
 - If a match is called before halftime by the referee due to weather, the match will be reported as a 0-0 tie. If the match is called after halftime by the referee, the score will be reported at the time the match was called.
- If a referee does not show-up for a scheduled match, the match is reported as a 0 – 0 tie.
