- Pre-meeting with A/C's was called to discuss an LRC request to permit a 13 year old to play on their U12 team. All A/C's were in concurrence to permit this player on the team.

- Sean from DC United spoke about the current status of the team
  - US Open Cup will be held at the stadium on September 2<sup>nd</sup>.
  - FCYSL Day will be Sunday, September 27<sup>th</sup> – discounted tickets will be available.
- Gene Long spoke on behalf of WMSOA – no changes in the Laws of the game this year.
  - Referee class had close to 70 participants, 52 of them were from the Frederick area.
  - Please respect the new referees - many of them will have no experience when they first take the field.
  - Request from the A/C's and coaches to reiterate the rule modifications to the referees for the U-8 age bracket.
- Scott Eslick spoke on behalf of MSYSA
  - E-license class will be sponsored by TCSC – contact Clifton Williams for more information.
- Bobby noted that participants in the sportsmanship class need to pre-register 2 days before the class.
- Four red cards from the spring season were reported not including the U16/U19 age bracket.
  - Reminder that coaches from each team and each area must report the red cards to Bobby and/or Jill the same day as the occurrence.
- Bobby reiterated that only the A/C's can declare a rain-out for their area and it must be 2 hours before the match is scheduled. The referee does have the ability to cancel the match if the field is deemed unsafe.

- Jill distributed the schedules to the A/C's.
