  - Fall issues

      - Coach suspended for 1 match
      - Player suspended for 1 match
    - Coaches' behavior on sidelines was reported and the specific A/C's were notified – coaches were also warned.
    - Bobby reviewed multiple matches throughout the county – referee's were provided feedback where necessary
    - MSYSA recommends against names on the back of jerseys.
    - Carded players can not play on teams below a power ranking of 5
    - Rules were clarified regarding players playing within the same age group.
    - There will not be any make-up games after the 1<sup>st</sup> of November
    - Roster issues – rosters are not provided to opposing coaches or A/C's. If there is a question, it will be reviewed by Bobby or Jill.
      - Tourney teams are only to be comprised of members on the rosters on record. No guest players are permitted.
      - The board will review moving teams from division 3 to division 2 for the tournament based on the regular season record.
  - Reviewed tourney rules
  - Bobby requested we upgrade the Washington Freedom tickets to priority seating. GVAA motioned for all bur FCF voted for the upgrade.
  - MSYSA will implement mandatory background checks effective January 1, 2010 for all restored adult team officials.
    - MSYSA website should be updated to show potential sources for this service.
    - FCYSL (Bobby will submit to MSYSA all requests if they are in his possession by February 28, 2010.
