- Treasurer's report was reviewed and approved.
 - Reconciliations have been updated and will be distributed in April 2010. Monies that are due to areas will be credited to future registrations.
- WMSOA's updated contract was accepted with the changes to the assistant referee fees.
- East/West division discussion – the current method of division/power rankings will continue unchanged.
- State mandated background checks
 - Examples from two companies were distributed
 - Questions was raised as to whether the requirements for the background investigations were too stringent.
 - Scott Eslick, representing MSYSA, indicated that it was up to the individual areas to permit a volunteer to continue coaching if that individual was flagged as part of the background investigation.
 - If an area decides to override the flag, the area must notify MSYSA that they are proceeding.
 - No coach or assistant coach will be permitted on the field without a background investigation.
 - A summary e-mail to Bobby is sufficient to document that the area completed the background investigation.
- Questions were raised about what the participants receive from MSYSA for the annual \$6.50 registration.
 - Scott Eslick will investigate what all is included in the fee.
- Nominations were made for the President and Secretary's position.
 - Bobby Riggs was nominated for President
 - Doug Connelly was nominated for Secretary
 - Both nominations were from WYSA
 - Nominations will close at the March meeting and elections will occur at the April meeting.
- Old business – Review of Fall Tourney
