- Meeting was called to order by Bobby at 7:15 PM.
- Meeting minutes were reviewed and approved.
- Treasurers' report was reviewed and approved.
- Officers were confirmed, President – Bobby Riggs, Secretary – Doug Connelly
 - Bobby Riggs II will take over as Vice President to finish out Bobby's term.
- Discussion or reschedules
 - All Washington county cross country meet change was granted by the Judiciary Committee
 - TCSC requested a time change for Prom – Judiciary recommended a minimum \$100 fine.
- By-laws need to be amended to permit players to move up an age bracket to play on two teams, but can not play on multiple divisions within their age bracket – passed 19-yay, 0-nay
- Red cards – referees were requested to reinforce the use of red cards for profanity and foul language.
 - Reminder that red card notification need to come from both coaches, both A/C's and the referee – copies to both Bobby and Bobby II. The card should also be included in the score reporting to Jill.
- Parents need to be reminded to keep comments to themselves and to not approach other players to discuss the match, the results or their skills.
- Chris Mills representing Locomotive Football Club spoke to the group about the formation of their club. Discussion ensued – passed 16-yay, 0-nay.
- Reconciliations – Question about the weather related reschedule fees.
- Tournament Patch and Trophy pick-up will be 7:00 on June 2nd
- Old Business – extra DC United tickets are available
- New Business – Washington Freedom wants to bring members of the team to Frederick County in support of a media event.
 - MSYSA – we have an opportunity to nominate anyone from our organization for volunteer of the year
 - New policy for head injuries – the doctors are enforcing a two week rule for rest for the player
 - If a youth has a cast on an arm, they are permitted to play with an excuse from the Doctor; the referee has to determine if the cast is safe enough for the other players.
 - FCYSL does not have a specific policy for permitting play with a cast on.
