- Meeting was called to order by Bobby at 7:15 PM.
- Secretaries report was reviewed and approved
- Treasurers report was reviewed and approved
- Nominations for officers occurred:
 - Bobby Riggs II – Vice President
 - Doug Connelly – Treasurer
 - Nominations will be open for 30 days – any other nominations should be forwarded to Jill or Bobby in the meantime.
- U8 format small sided (4 x 4 w/goalie) discussion continued. Format would be 10 minute quarters; substitutions at any time; kick-in's would replace throw-in's; field size is approximately 25 x 35; teams would be 12 players and halve at game day; statistics have shown 4x the number of ball touches; suggest that the format would be localized to limit travel. Discussion continued, but was not brought to a vote to be adopted by the league.
- Bobby II has been monitoring both red and yellow cards through the season.
 - There have been 20+ yellow cards and 6-7 red cards
 - Reiterated the specific policy for reporting red cards.
 - Suggestion provided to include the red card reporting requirements on the quick reference cards
- Bobby has received over 26 requests to reschedule matches since the start of the season. Only one request was granted since it conflicted with a primary school function.
 - A proposal to modify the reschedule requirements in the by-laws was read to the A/C's. Discussion continued.
 - A motion to accept the reschedule proposal was made and seconded. The motion did not carry with 1 vote Yay, and 16 votes Nay.
- Participation in the DC United Spring Soccer camp is well below expectation – reminder to A/C's to get the information out to all the participants.
- The MSYSA annual meeting will be 18 June, 2011
- Meeting was adjourned.
