Meeting Minutes

March 14, 2012

Next meeting: April 25, 2012, 7:00PM, St. Paul's Church, Myersville, MD

- Meeting was called to order by Bobby I at 7:05 PM.
- Secretary's report was reviewed and approved.
- DC United representative spoke about their program
 - HAYSL, HYMCA and LFC will host a DC United camp July 23-27 at the Hagerstown Fairgrounds
 - May 19th is FCYSL night at DC United
- Mike Truax spoke on behalf of WMSOA – there are no significant rule changes this year
 - WMSOA lost approximately 100 referees over the past year while 40 new referees were added
 - WMSOAs mentoring program will continue to assure the new referees have the proper oversight
 - Reiterated the no jewelry stipulation
 - Offside's clarification – the referee must observe separation between the players
 - Handball must be considered intentional
- Sportsmanship classes will be held on March 17th at 9AM and March 21st at 7 PM
- Head injury – If the player is taken to see a physician for a head injury, the player is required to sit out the next two weeks.
- Red cards – the offender is automatically suspended until the offense is reviewed and dispositioned by the judiciary committee
 - Both coaches, both area coordinators and the head referee need to submit reports the same day
- In the event a referee does not show up for a schedule match, only a certified WMSOA referee can call the match if available and the referee must be agreed upon by both coaches. If a referee is not available, the match may continue as a scrimmage and will not count towards a team's record.
- Reminder that all goals must be anchored and it is the responsibility of the home team.
- Reminder that a maximum of three coaches are permitted on the player's side of the pitch.
- Reminder that all coaches are required to have completed sportsmanship training.
- Rainouts can only be called by the area coordinator for their home fields. Only the board can call a county wide rainout. A referee can call the game based on unsafe field conditions. If a game is called after the completion of the half, the game is recorded as complete with the score at the time of the call. If a match is called before the half, it can be rescheduled.
- There will be a zero tolerance policy on approaching the referees.
- The Administrators position contract is due for renewal. A solicitation will be sent out to the areas.
- Schedule packages were distributed to each of the areas.
- Meeting was adjourned.
