- Meeting was called to order by Bobby I at 7:10 PM.
- Secretary's report was reviewed and approved.
- Treasurer's report was reviewed and approved.
- Administrators' contract was reviewed and renewed.
- Ft. Detrick Youth Sports petitioned for membership
 - By-laws are available on-line; all coaches are trained; soccer fields will be available this fall
 - Question on gate check – photo ID for adults over 18 required
 - Interested in placing U8's thru U12's into FCYSL and maintaining U6's in City of Frederick program.
 - Motion made and passed.
- Update to By-laws – Soliciting volunteers to form a committee to review the by-laws and update over the next three (3) months.
 - Requested feedback to the committee for proposed changes to the by-laws.
- Presidents report – visited 12 matches (not by choice)
 - Reiterated that no guest players are permitted and all players that have participated must be on the roster.
 - As stated in the by-laws, the maximum number of adult volunteers on the players side of the field is three (3).
 - Only A/C's can call matches due to weather and the matches need to be cancelled a minimum of 2 hours before the scheduled start time.
 - Referees are not too approached during or after the matches.
 - All spectators are reminded of the need for sportsmanship.
 - WMSOA has reiterated the need to eject participants upon hearing profanity.
- VP report – reiterated that approaching referees will not be tolerated and invoking penalties on parents for infractions of the by-laws.
- May 19 will be DC United night for FCYSL – looking for youth ambassadors for the evenings match.
- The President and Secretaries position were approved for an additional 2 year term.
- The U8 age group will be regionalized for the Fall 2012 season.
- Coaches are reminded to be at the mandatory coaches meeting prior to each season.
- Discussion on the referee's qualification for the matches that they are managing
 - Can a referee rating system be put into effect?
- Meeting was adjourned.
