- Meeting was called to order by Bobby I at 7:10 PM.
- Secretary's report was reviewed and approved.
- Treasurer's report was reviewed and approved.
- Waiver Requests were brought forward by PVYA, CSSC and GVAA and were approved.
- Frederick Soccer Union petitioned to join our league. Motion to accept their membership into our league. Non opposed.
- Move up, move down list was reviewed and teams were moved as needed.
- Bobby discussed the possibility of having a U16-U19 division this fall. It will start 2 weeks later than the normal season. Teams can be formed after high school tryouts. Players can be combined. The location for these games will at Hillcrest. Bobby will send Jill information about this division and she will pass on to A/C's. PVYA, GVAA and MAYAA may have teams for this age group. After High School tryouts are done, email Bobby or Jill so we can see if we have enough teams to schedule that age group.
- There was more discussion on moving D2 teams up to D1 so we can have that division this fall
- Discussion on the Spring tournament was held.
  - Discussion about a possibility of seeding the tournament was discussed.
  - Bobby to talk to Mike Truax regarding referees turning in scores for our games so we can have a better look at the teams for the tournament. When scores are not turned in it is hard to determine the placement in the end of season tournaments. Bobby felt the way we are doing the scores with A/C's turning in the scores to Jill would be a lot quicker than having referees turn in scores. It was decided to keep it the way it is. Coaches need to turn in scores to A/C's and A/C's need to turn them into Jill.
  - Bobby or someone from the Board was at almost every site for tournament. Only had two problems, otherwise tournament went well. CYASC tournament had a video set up so kids could play videos free for a couple hours in between games.
- Mentoring Day will be held at TJAY-Monocacy MS fields on August 25<sup>th</sup>.
- BY-Laws committee consists of Curry Palm, Chris Wolcott and Ed Sigler. If anyone else would like to join the committee they are free to contact Bobby. Main issues in the review of By-Laws will be Code of Conduct and Red Card appeals and process. If you have any comments or changes you would like reviewed for the By-Laws committee, please contact Bobby Riggs.
- Sportsmanship classes will be held on August 25<sup>th</sup> at 9:00 am and September 5 at 7:00 pm. Location is still undetermined will let everyone know as soon as he has it confirmed. Make sure you register two to three days prior to classes. Cost of classes is \$5.00. Please let your coaches know.
- Coaches meeting scheduled for August 29<sup>th</sup> at Myersville Elementary School or Fire hall. Bobby will talk to Fire Hall to see if we can have it there, but will not pay to use the building. Discussion was made about the coaches meeting being mandatory. Thought at least first time coaches should attend. No decision was made on this matter.
- Question about coaches attending Sportsmanship classes and if there was a record of all coaches that attended. Bobby said yes, he has a record of all coaches that have attended. He and Bobby, Jr. are working on a database for coaches that have taken the classes. Bobby has the master copy if anyone needs to check to see if their coaches have attended.
