- Meeting was called to order by Bobby I at 7:05 PM.
- Secretary's report was reviewed and approved.
- Treasurer's report was reviewed and approved.
- MSYSA representatives will be at the February 6th meeting for a Q&A session – please forward all your questions to Bobby I prior to the meeting
 - An E license will be offered approximately the end of Feb, early March of next year
 - Will be 8:00 to 5:00 on both days of the schedule weekend
 - Cost will be \$85.00 per participant – a license will be issued upon successful completion
 - Must register on-line and will require preparatory work prior to the session
 - A D license will be held in the summer of 2013
 - Will be 8:00 to 5:00 on both days of the scheduled weekend over two consecutive weekends
 - Cost will be \$180.00 per participant - a license will be issued upon successful completion
 - A coaching clinic will be held at no charge prior to the start of the Spring season
 - Soccer Directors and Board Officers are covered by MSYSA liability insurance
 - It is not a primary coverage policy
 - Effective in the Spring season, there will no longer be waivers granted for players to play down an age group. MSYSA rules do not permit it and insurance will not cover the participants
- Discussed continuing buying the DC United game tickets
 - FCYSL was required to pay the field usage fee for the two clinics sponsored by DC United in 2011
 - Vote to continuing purchasing the tickets passed with 10 Yay and 5 Nay votes
- Question was raised on rescheduling and who arranges the referee coverage – the administrator handles MD in-state reschedules, the A/C's handle out of state reschedules.
- Discussion on red/yellow cards this season – overall the number was down from previous seasons.
 - General feedback was the coaches and parents were better behaved.
 - The quality of the referee's seems to be improving too
- Bobby I will be the point of contact for questions during the tournament weekend.
 - Reminder that all teams must complete all of the matches scheduled in the tournament.
- Meeting was adjourned.
