- Meeting was called to order by Bobby I at 7:05 PM.
- Board members along with the Manager were introduced.
- Secretary's report was reviewed and approved.
- Washington Spirits owner spoke about the new ladies team
 - April 27th will be FCYSL night at the Germantown Sportsplex
- DC United representative spoke about the team – chalk talk will be 23 March
 - May 25th will be FCYSL night at DC United
 - Bobby announced how the DC United tickets would be distributed to the A/C's
- Mike Truax from WMSOA spoke regarding the referee association
 - New rules – any outside tape or elastic must match the stocking color
 - Can not score directly on a drop ball
 - Head scarves are legal to wear (preliminary ruling)
- Two red cards were noted in the Fall Season
- No schedule changes – only for weather make-ups – only the A/C can call the matches for weather
- Reminder of the minimum number to play – 4 players for 7v7 and 7 players for 11v11
- Lightning delays – the match is considered complete if delayed after the half and not completed. If before the half and not completed, it can be rescheduled.
- Only the referee can delay or stop the match for field conditions, not the coaches.
- If a referee does not show up, only a certified and registered official can referee. If none is available, the teams may scrimmage, but the match is not rescheduled and not completed.
- Reminder to all coaches of the score differential rule and to pull players once in effect
- There must be 5 reports for a red card; the referee, both coaches and both A/C's and the individual that was carded can not participate until notified by the judiciary committee.
- Unsporting behavior will be reviewed by the board and/or Judiciary committee even though a red card is not issued.
- Profanity will not be tolerated
- A maximum of 3 coaches are permitted on the coaches side and all must have Sportsmanship cert
- Referees are not to be addressed
- MSYSA representative will be at the next FCYSL meeting to answer questions
- All areas must be in good standing with MSYSA to participate in FCYSL.
- Meeting was adjourned.
