- Meeting was called to order by Bobby I at 7:08 PM.
- Secretary's report was reviewed and approved.
- Treasurer's report was reviewed and approved.
- Frederick County Soccer Club was introduced to the coordinators by Mark Vanderholtz, president and director (previously of Frederick Union Soccer). FCSC is seeking to place 2 U12 girls' teams in FCYSL for the Fall season. By Laws previously forwarded to FCYSL board. FCSC home pitch Fall will be Old National Park. Coordinators present had no questions. Motion made to accept made and seconded.
- Washington Spirit - No tickets purchased - Will rollover any tickets to next season
- Spring Season issues
 - Young referees
 - Need to prohibit air horns—maybe spectator observers wearing distinguishing hats?
 - Eliminate spectator comments to players
 - Bobby's focus will continue to be parent/spectator conduct – particularly derogatory comments anytime, but especially parent comments to referees
 - Bob Stum (Waynesboro) asked if individual clubs/areas address all the above issues with parents
 - Bobby noted that coaches should monitor team's parents
 - Parents should be encouraged to attend Sportsmanship Clinic—Bobby would not charge the fee unless the parents are certified for a green card
- Roster issues - ACs are required to know which players are on which teams in their Area
 - Coaches will be suspended if found putting players on a team "to fill a roster" for ANY game, if an "outsider" (classic or premier player)—unless rostered on an FCYSL team for the season
 - If penalty/sanction handed out—must be enforced
- Coaches who intentionally pull team off pitch "for safety of players" will be reviewed. This should never happen. Will be an automatic forfeit. There was considerable discussion on this subject. PVYA AC said that as parents, coaches feel responsible; coaches should talk with ref or other coach in runaway scoring games; remember game etiquette; coaches should not allow over-zealous" play by their team
