- Meeting was called to order by Bobby I at 7:03 PM.
- Secretary's report was reviewed.
- Officers were introduced.
- DC United representative spoke on the team and appreciation for continued Frederick County support – FCYSL night will be October 12, 2013.
- WMSOA representative spoke on behalf of the referee association
 - Fewer people joined this year compared to those referees not returning
 - Absolutely no jewelry of any kind is permitted – medic alert bracelets are permitted but must be taped
 - Tape on socks must be the same color as the sock – same for under armor shorts – must match the outside short color
 - Shin guards are required and suggested to be age appropriate
 - New rule – if a ball burst during a PK, the PK can be retaken
 - Referee only needs to stop play if something (stray ball) interferes with the active play
 - FIFA has tried to clarify offside's ruling and offside's will be enforced as it has been until the clarifications are fully understood and training is completed
- Reminder to A/C's that all coaches need to have background checks completed and reported
- Coaches are responsible to make sure all players are on the final rosters which will be due at the September meeting
- Red cards must be reported the same day as they are issued by both coaches, both A/C's and the head referee
- All yellow cards should be reported to the Vice President for tracking purposes
- Emphasis will be on spectator conduct this season
 - FCYSL Code of Conduct was distributed and expected to be given to all parents
- Only three coaches are permitted on the coaches side of the field – no other adults are permitted
- The weather policy was reviewed – only A/C's can cancel their fields based on condition
 - The referee can stop the match based on field conditions, or Lightning
 - If the match is called before half, it can be rescheduled, after half, the score at the stoppage of play is the final score.

- Meeting was adjourned.
