Meeting Minutes

September 25, 2013

Next meeting: October 23, 2013, 7:00PM, St. Paul's Lutheran Church, Myersville, MD

- Meeting was called to order by Bobby I at 7:09 PM.
- Secretary's report was reviewed and approved
- Treasurer's report was reviewed and approved
- Question on the slide tackle ruling for FCYSL – nothing in our by-laws prohibits slide tackling
- Bobby reported that 2 coaches had been suspended for 2 matches for the Fall season
- One red card had been issued in the first 3 weeks of the season for intentional use of the hands to prevent a goal scoring opportunity in the box – appealed to Judiciary Committee – was not overturned
- Clarified the escalation protocol for concerns – the path starts with the coach, then the area coordinator and finally the BOD or the Judiciary Committee
 - Requested the A/C's relay the hierarchy to their coaches to disseminate to the parents
- Discussed the D3 division for upper age groups (U12 and U14)
 - We have tried odd age groups (U11 and U13) in previous years unsuccessfully
 - We will continue with the current move-up system between seasons and for the tournaments to adjust team placement based on their records
- Bobby has been approached to see if there is additional interest in a non-FCYSL sponsored tournament after the end of season FCYSL tournament that could include non-FCYSL teams or combined FCYSL teams
 - Discussion ensued, suggesting it might be better to have it in the Spring since there is more daylight and better weather
 - Both WYSA and MAYAA (U8) will be hosting tournaments after the FCYSL tournament
- The organization will purchase another season of DC United tickets to used for the volunteers in the organizations
- Waivers will be maintained by all the areas, similar to what is currently in place for the birth certificates.
 - Each area will either submit the rosters showing each player has accepted the waiver, or a statement from each area that all players have accepted the waiver of liability.
- Meeting was adjourned.
