- Meeting was called to order by Bobby I.
- Secretary's report was reviewed and approved
- Treasurer's report was reviewed and approved
- Second half of the season was better than the first half – addressing issues with guest players
- Reminder that there is no provision for guest players during the season or during the tournament. All players that are participating must be on the final adjusted roster for each team. Illegal rostering is taken very seriously and penalties are defined in the by-laws.
- Reminder that rainout reschedules need to be coordinated between the two areas; home area should offer 3 possible dates and can be coordinated between the two affected coaches.
- Clarified that red cards received on the final match of the regular season would prohibit the affected individual from playing in any of the tournament matches. If the team is not participating in the tourney, the red card will carry over to the next season.
- Question on head injuries and optional headgear for goalies – will be at each areas discretion
- Fall tourney rules review
  - Only rostered players are permitted to play in the tourney – no combining of teams or guest players
  - Only coaches are permitted on the coaches side of the field and must be within the coaches box
  - There are no substitutions during corner kicks.
  - Sundays matches will revert to Eastern Standard Time – make sure all of your clocks are reset
  - There are no penalty kicks on the Saturday matches – ties will be decided by the rules in the Appendix
  - If a red card is issued, the participant is out for the entire tournament.
  - DC United will be at the Monocacy Middle School Tournament on Saturday.
  - Questions on the schedule and why there are such long durations between some of the matches
  - The tourney is not seeded, it is a blind draw
- Meeting was adjourned.
