- Meeting was called to order at 7:05 by Bobby I.
- Secretary's report was reviewed and approved
- DC United Representative spoke on behalf of the team
- Washington Spirit Representative spoke on behalf of the team
- Mike Truax with WMSOA discussed the referee association
 - Reminder of the rule that tape must match to color of the socks
 - Referees will enforce the no jewelry rule
 - Force of mechanics – it is not a foul if the it is clean – but do not encourage players to push
 - Lost 109 referees from last year, only 30 new referees in training
- Frederick County Parks and Recreation fields would not be available until Monday – will need to assess on Friday whether referee mentoring day can be accommodated
- Frederick City Parks and Recreation fields are being closed on a day by day basis
- Scheduled matches will start on March 29, 2014
- Reminder by Bobby I that the referees are not to be approached
- Profanity will not be tolerated
- A/C's and coaches are responsible for rosters to insure the ages are correct – must be finalized by the next meeting and cannot change after the April meeting.
- No waivers will be granted
- All red cards, including those shown to a spectator must be reported by both coaches, both A/C's and the referee by 9:00PM the evening that the card was issued.
 - Yellow cards will also be tracked
- Limit of 3 coaches on the coaches side of the pitch and all must have completed sportsmanship training
- Weather related postponements – only the board can call a league wide rain out. Only an A/C can call an individual field weather delay, and it must be 2 hours before the scheduled match. The referee can call a match based on the safety of the field.
 - If a match has been postponed due to weather, the home area should provide 3 available dates for reschedule and can include week nights.
- MSYSA is interested in conducting E, D and/or C licenses in the area
- Sportsmanship classes will be held on March 22nd @ 9AM and March 26th @ 7PM
- Meeting was adjourned.
