August 24, 2014

Next meeting: September 24, 2014, 7:00PM, St. Paul's Lutheran Church, Myersville, MD

- Meeting was called to order at 7:10 by Bobby I.
- FCYSL is planning on hosting D, E, and potentially F license courses in early 2015. The second half of the D license course will be just before the Fall 2015 season.
- MSYSA will host their Annual General Meeting (AGM) on 14 September 2014 – all member organizations are encouraged to attend, and if they cannot, Bobby I can vote their proxy for them.
- Mike Truax representing WMSOA discussed some of the new or modified rules of the game
 - Scarf's are permitted as headwear and they must match the uniforms color
 - There shall be no advertising on the uniforms
 - No jewelry is permitted – earrings are not permitted to be taped
 - All referee concerns should be included in the score reporting matrix
 - Offsides clarified as a player being forward of the last defender when the ball is kicked and must be in active play
- Michelin and Tire World representatives spoke of the fundraiser and ball give away.
- Carla Thompson, MSYSA's Technical Director, spoke on training and player retention
 - MSYSA's goals are to improve coaching education and improving player development/retention
- Reminders:
 - All matches are to start on time
 - Red cards will be issued for foul language
 - Referees are not to be approached on the field or after the match
 - Weather delay's and cancellations – only the BOD can call a league wide rainout
 - Only the areas can cancel their individual fields and be completed 2 hours before the match
 - If lightning is witnessed, and the match can not be completed, the score at the stoppage will be the final score (if it was at halftime), but the match may be rescheduled if the stoppage occurred before the half.
 - All soccer goals are to be anchored – nets are not required
 - All red cards are to be reported by 9:00 the evening the red card was issued; reports are required by both coaches, both area coordinators and the center referee
- Final rosters and tournament registrations are due at the September meeting – no other players may be added to the roster after that time, and guest players are not permitted in the tourney.
- Meeting was adjourned.
