Next meeting: October 22, 2014, 7:00PM, St. Paul's Lutheran Church, Myersville, MD

- Meeting was called to order at 7:05 by Bobby I.
- Secretaries report was reviewed one correction to previous minutes: Karla, not Carla
- Bobby reviews problems with the Tire World giveaway
 - Not enough balls, not enough coupons
 - No show for Sportsmanship Class
 - Lots of balls for giveaway at the Great Frederick Fair, but not enough for BCRC, WMAA or TJAY
- MSYSA AGM info:
 - Bobby had proxy vote authorization for GVAA, FSK, BCRC, TJAY, WMAA and TCSC
 - There will be changes to the rules—one vote per area, not by # of players
 - Karla Thompson will do coach class for free—but Area Coordinator should contact her
 - Per Bobby, Karla is very good and very technically expert
 - Still waiting for dates from Doug to schedule License level courses for Spring 2015
 - Guest players for tournaments permitted, unless it interferes with local league rules—must be approved to be allowed
 - Maybe a Recreational Tournament –not carded, and no carded players; goal is to improve players; will
 make local leagues better
 - Send ideas to Bobby—Bobby will take proxy authorization thru Saturday 27 Sept 2014 (will save \$60 registration fee for the individual area)
- Final Rosters TONIGHT—no players can be added after tonight—for the balance of the season or for the Fall Tournament
- Tournament schedule 1 and 2 November; any make up games must be finished before the Tournament
- So far this season:
 - 1 RED card for profanity; 2 game suspension (almost voted for a 1 yr suspension)
 - Generally, all has gone well
 - Refs should be enforcing center field substitution—should announce at the beginning of the game not halfway through (acknowledged that it lengthens sub time)
 - Referee feedback has been positive
 - One issue: injury, whistle blown, coach's attention; goal scored (one AR did not hear the whistle, mentor heard whistle before the goal): clarification requested, but cannot protest the game, file report, Bobby will check with Mike Truax
 - Substitutions have been problematic; should be allowed to position players
 - Should be no advantage or disadvantage due to substitutions
 - Goal differential 5 not 7 require one player to be removed
- Requests for Player Waivers
 - Bobby initially denied all requests (for cross country meets, band activity (MS to play at HS games);
 parades; playing down—a total of 5 denied requests; religious exemption for Yom Kippur-day game
 - Stephanie advocated for her team's coach and 2 players for Yom Kippur (after discussion, Bobby will take a silent vote)
 - REMINDER: it is the coach responsibility to communicate with their AC so the AC can request special accommodation AT THE BEGINNING OF THE SEASON
 - Parents advocated for an autistic child to be allowed to play with his classmates' team despite being 3-4
 months past the age cutoff—per MSYSA, up to local league; after parents' presentation, a unanimous
 vote to allow the exception
 - Open discussion of Waiver requests:
 - o "broad swath" not working
 - o Needs to be a mechanism for variances and tolerances
- Overall, good season so far, good games. Bobby commended the ACs for "coming down on the Coaches"
- Meeting was adjourned.
