- Meeting was called to order at 7:00 by Bobby I.
- Secretaries report was reviewed and approved
- Referee issues:
 - Two back to back U14 matches were not covered – only a center referee was scheduled
 - Need to clarify to the referee associations that a minimum of two referees need to be scheduled for 3 man systems
 - Reinforced the need to have substitutions formally from the midfield point
 - Clarified that referee feedback through the season is on an individual, not group basis
 - Referees have the ability to eject (red card) or dismiss a person from the field
- Received spectator conduct complaints from the referee association
 - Warnings led to confrontations with the coaches
- Tournaments outside of FCYSL permit teams to obtain a one day pass for registration
 - Discussion about whether this constitutes carding the team and the need to register as a division 1 team the following season
 - No specific issues with this for the Spring season – will evaluate the team's performance in the FCYSL end of season tournament
- Any red cards issued on the last match of the season will mean that individual is not eligible to participate in any of the end of season FCYSL tournament
- Reviewed the tournament schedule.
