March 18, 2015

- Meeting was called to order at 7:00 by Bobby I.
- Secretaries report was reviewed and approved
- Washington Spirit representative spoke
 - May 16th will be FCYSL night at Washington Spirit
- DC United representative spoke
 - May 30th will be FCYSL night at C United
- Mike Truax with WMSOA referee association spoke
 - Reiterated the rule that any head coverage must be black or the matching color of the uniform
 - Political statements cannot be worn on the jersey or undershirt
 - Absolutely no jewelry is permitted to be worn – no exceptions
 - Mike thanked the board for the response to the incident during the Fall tournament
 - One third of the referees will not be returning from the Fall season
 - Reiterated the no tolerance policy including dissent
 - Referees must show a card for dissent
 - The FCYSL Board reserves the right to review ejections even if a card was not issued
 - Presidents cup is the weekend of 11 April
 - Next WMSOA training will be in August
 - ~~Much of the training is now on-line~~
- FCYSL Rules and Policy discussion
 - Zero tolerance policy will be enforced
 - Board members have the authority to remove individuals from the matches
 - Reminder to respect field marshals at all of the locations
 - Reminder to have current background checks for all coaches
 - Only 3 coaches are permitted on the coaches side – all must have taken the Sportsmanship class
 - Coaches are responsible for having a legal roster for each match
 - Red card policy – must have 5 reports (referee, both coaches, both A/C's) – the individual is suspended until reviewed by the Judiciary committee
 - If sufficient players are not available for the match, the team will need to forfeit
 - County wide rainout can only be called by the FCYSL Board
 - Only an A/C can call a cancellation for their field and at least 2 hours in advance
 - The referee can cancel on the field for unsafe playing conditions or weather
 - In the event of a cancellation, the home team must suggest 3 dates for the reschedule
 - If no referee shows up, the match will be recorded as a 0-0 tie
- Meeting was adjourned.
