- Meeting was called to order at 7:05 by Bobby I.
- Secretary's report was reviewed and approved.
- Final rosters are due at tonight's meeting no additions or changes are permitted after this meeting.
- Will review roster verification at the October meeting.
- Fall review – question on age eligible High School participants – the by-laws state High School players are not permitted to play U14 – clarification that they can play age appropriate U14 as long as they are not playing on a High School soccer team.
- Clarification on scheduling process and how much is completed by the software versus how much is hand scheduled.
- Bobby II commented on how well the season has progressed with very few issues – one area in particular has gone above and beyond handling parent issues.
- Bobby I commented on the positive feedback from the coaches for the referees
- The birth date will change for soccer to correspond to the calendar year (January 1 – December 31). You will not be able to turn the age of the bracket during that calendar year.
 - Plan to go into effect starting with the Fall 2016 season.
- WMSOA contract was brought forward for review and the fees were provided.
 - Questions on how referee feedback is handled and how feedback is provided to the A/C.
 - Bobby II suggested an amendment to the contract
 - Proposal to add a grievance process to the contract
 - Upon concurrence with WMSOA, the contract language will be distributed to the A/C's.
- Field and goal sizes with MSYSA will change at the end in 2017, along with players per team.
 - FCYSL will need to discuss if we will adopt these suggestions.
- DC United renewal – no price increase if we renew contract.
 - Request to look at the tickets for women's soccer also.
 - Bobby will bring prices to the next meeting for further discussion.
