- Meeting was called to order at 7:15 by Bobby I.
- Julia with Washington Spirit spoke
- Malcolm Johnson with D.C United
- Randy Rupp-Thanked all participants in the Referee mentoring day
- Mike Truax spoke on behalf of the referees association
  - No Jewelry, no earrings-no covering of jewelry and it is the coaches responsibility
  - Sportsmanship cards - Referees checking for cards. Coaches may have cards electronically or paper.
  - Rule modifications
    - MD-New head rules - U8/U10 cannot head-Foul=indirect free kick. Unintentional=Drop ball. Play stops by referee not coach. Coach can take player out. Quickly check player; slows game but game time continues
    - State of MD mandate-all ages, game on public fields (all sports). If the referee feels slight concussion the player is out for balance of game. Strict concussion protocol by medical professional come back to that game. Any elbow to head or head to head, staggering. If taken to MD/ER/PCP with any mention of concussion the player is out for 2 weeks. Tournaments from now on must have M.D. at the field
    - New offside rule- New interpretation. One offense-2nd offense touched by defense=onside attempt to play ball. Center referee can ignore AR flag if any defender plays the ball.
- FCYSL Rules and Policies
  - Concussion-Parent responsibility to alert coach. Coach can ask-get a note. Second Concussion=6 months out if it's within 6 months
  - Coach's Card-Sportsmanship-Hardcopy or electronic copy. Must have at beginning of game. Green or Blue card.
  - Sidelines-One head coach and 2 assistant coaches (+ parent if card) - Rostered players only
  - U12 and below-parent-run side flag. Only raise flag. No refereeing and No coaching etc. Just out of bounds (even certified refs)
  - Sportsmanship Clinic - March 30, 2016 at St. Paul's Lutheran Church
  - Bobby Riggs II gave out President and Vice President contact information
  - Referee amount of fee change is on cards
  - Bobby reviewed weather rules - Official score-if not 1/2 time can make up
    - no double header games-1 per day - time does not stop for anything - starts when referee starts-referee late, injury
  - Dress policy
    - jerseys must match, must have number even if double rostered - no tape on socks; unless same color - shin guards inside socks - no cardboard/flipflops for shin guards
  - No referee-play as scrimmage
  - Major changes coming Fall 2016 for 2017
  - Meeting was adjourned.
