- Meeting was called to order at 7:05 by Bobby I.
- · Washington Spirit representative spoke
 - FCYSL night will be September 3rd
- Mike Truax, WMSOA representative, spoke of the law updates which were effective June 1st:
 - The kick-off does not have to move forward
 - The ball must move, can no longer just be touched to be in play
 - Tape on socks must be the same color as the sock
 - Reiterated absolutely no jewelry is to be worn
 - Shin guard must be replaced prior to the next dead ball player no longer has to be sent off
 - Injury with a card the injured player must leave the field
 - If the keeper kicks the ball into his own goal, it is a corner kick for the opponent
 - USSF rule book is available on-line and downloadable
 - No new referees for this season, a class is planned for September refer to the MSYSA website
 - No heading of the ball at U9 and U11 level- intentional heading will be awarded an indirect free kick, unintentional will be awarded a dropped ball
- First aid/concussion class will be 9/7 and 9/8 at 6:30 with a fee of \$25.
- Sportsmanship classes will be the 7th and 14th of September
- Only A/C's can call a match for their fields for weather and it must occur 2 hours ahead of the match – referees can call a match based on field conditions
- A reminder that the new age group date definition is through the calendar year
- There can be no more than 3 coaches on the coaches side for each team
 - All coaches must show evidence of a Sportsmanship card to the referee prior to the match
- Referee feedback should be submitted with the scores
- Red cards must be reported the same day as the occurrence
- Scheduled matches where a referee does not show may be played as a scrimmage
- In the event a referee is needed for a 1 man match (U9 or U11), the field marshal may pull a referee form a 3 man system is available at the same field.
- Players are permitted to wear certified protective head gear.
