Meeting Minutes

March 15, 2017

Next meeting: April 26, 2016, 7:00PM, St. Paul's Lutheran Church, Myersville, MD

- Meeting was called to order at 7:05 by Bobby I.
- Need to incorporate the By-law changes and review with all the A/C's.
- WMSOA Representatives spoke:
 - Handball – defined as 'deliberately' hitting the ball with your hand or arm
 - Playing on the ground – permitted as long as the individual is not playing in a dangerous manner
 - Offside – must be in an offside position (less than two defenders between the player and the goal) as measured by the body part that is permitted to play the ball (not the arm or hand)
 - Many younger referrers are still developing – exercise patience
- 72 new youth referees will be available this Spring – many will be refereeing FCYSL matches
- If a 3 man crew is available at an adjoining pitch, one may go and referee a one man match if the assigned referee does not show-up
- All matches must start on time
- No jewelry is permitted – medic alert bracelets must be taped
- Background checks for all of the coaches are the responsibility of the Area Coordinators
- Coaches are responsible to ensure that the rosters are accurate and legal for each match played
- Only an area coordinator can call a match for their home field based on pitch/weather conditions
- Reminder that there is no rule that requires the goals to have nets
- Weather rule- there is a 30 minute delay for lightning – referees must still be paid
 - If the match makes it to the half, the final score is the score at the match stoppage. If the match does not make it to half, the match may be rescheduled as a weather delay.
- Bobby II reviewed the red and yellow card reporting procedures and Judiciary Committee review
 - Red cards must be submitted the same day
 - Red carded individuals can not play until ruled upon by the Judiciary Committee
- Sportsmanship cards must be carried or an electronic copy must be available to be shown to the referee at the start of the match.
- Only one match can be played per day – weather reschedules are not to be played on the same day as another already scheduled match.
- Meeting was adjourned.
