- Meeting was called to order at 7:04 by Bobby I.
- Secretaries report reviewed and approved
- Mike Truax spoke on the referee's association:
  - Requested that all referee comments be sent to Jill as part of the score reporting matrix
  - Rule/Law changes:
    - All decisions made by the officials shall be respected
    - Temporary dismissal – the referee can require a player to sit out 10% of the match time without substitution (will need FCYSL to adopt this policy)
    - Kick-offs can go backward and the kicker is permitted to step on the opponents side
    - Offside update – can be called if an offensive player intentionally steps in from of or impedes the defender
    - It is not the referees responsibility to keep the players form wearing jewelry, only to enforce the rule
    - U11's and below are not permitted to head the ball
    - Head pieces are permitted as long as they do not have tails
    - If the player has a cast, it must be wrapped with foam or bubble wrap – cannot be used as a weapon
- FCYSL policy
  - No plans to approve any schedule change requests
  - Matches will incur a 30 minute delay for lightning
    - The clock continues during the delay period
  - Red card notifications are required by 9:00PM the evening of the incident
    - Inputs are needed from both coaches, both A/C's and the referee
  - If a referee does not show for a match, the match may be completed as a scrimmage
    - The coach may request the use of a referee from a 3 man system if one does not show, but this is not a mandatory requirement.
- Fall 2017 schedules were distributed.
- Meeting was adjourned.
