- Meeting was called to order at 7:03 by Bobby I.
- Introduced Mike Truax representing WMSOA referee officials.
  - Overall reduction of certified referees available
    - Encourage the coaches to provide some latitude for the referee calls
  - Reiterated that the coaches are responsible for the players equipment, not the referees
    - Absolutely no jewelry may be worn
  - Offsides is difficult to call with a one man system
  - Question was addressed on unintentional head ball at the U11 and below level
    - Unintentional is a drop ball, intentional is an indirect free kick
  - Referee mentoring was cancelled due to insufficient team support
- All coaches will be required to show their sportsmanship cards when paying the referee
- All coaches and assistants must pass the background investigation whether they assist at practice or matches. This includes parents that assist at practices and/or games.
- Rosters must be legal at all times
  - Final rosters will be due after week 4 of the season with no substitutions or guest players permitted
- Red card notifications must be turned in the evening they are received
- Reschedule requests must go through Bobby I and will be verified
  - Rain reschedules will be in accordance with the by-laws.
- The administrator will send out any tournament specific information directly to the coaches
- Referees are not to be addressed – all referee issues should be documented on the game reporting spreadsheet and submitted to the administrator
- Schedule packets were reviewed
- Weather guidelines were reviewed.
- Meeting was adjourned.
