- Meeting was called to order at 7:04 by Bobby I.
- Secretaries report was reviewed and approved
- Mike Truax spoke on behalf of WMSOA
  - No new rules this season for the youth level of play
  - Coaches are responsible for making sure that none of the players is wearing any jewelry
  - The Spring season illustrated many issues with parents and players reiterated that the coach is responsible for all of the participants, including the parents
  - Discussion during Q&A regarding lopsided scores – should players be added once the score differential is 5 as opposed to taking players off
  - Question regarding approaching the referee during a match – the BOD dissuades approaching the referee
  - WMSOA has 240 referees for the season, down 120 from 2 years ago
    - 18 new referees in the last class
- Older age groups will be monitored for behavior very closely for the upcoming season
- Referee assignments are reviewed the Friday evening before the weekend to assure coverage
  - If a referee does not show up, the match may be played as a scrimmage – this is not a reason to reschedule the match
- Red card reports are due by 9:00PM the night of the incident – 5 reports should be submitted
- 6 referees were removed from the FCYSL schedule by the completion of the previous season
- Weather delays – a half hour delay for lightning will be enforced
  - If the match is incomplete before the half, it may be rescheduled
  - If the match is stopped after the half, the score at stoppage will be recorded as a completed match
- Bobby I discussed the schedule changes after the schedules were complete
- League wide cancellation will be called by the President
- Reschedules will only be considered if it is a mandatory school activity that is in conflict
- Sportsmanship classes – 3 classes will be conducted before the start of the season
- September is a mandatory meeting for the A/C's – representatives from MSYSA/USSF will be in attendance
- Meeting was adjourned.
