- Meeting was called to order at 7:03 by Bobby I.
- Secretary's report was reviewed and approved.
- Treasurer's report was reviewed and approved.
- Confirmation of officers for the next two years.
 - Bobby Riggs I – President
 - Doug Connelly – Treasurer
- Build out lines must be in place for U9 matches – Manager will send out the link.
 - No punting and no head balls at the U9 level.
 - Referees have been reminded about enforcing the build-out line and to verify sportsmanship cards.
- Question on whether we want a fourth official at the tournament sites.
 - Fourth official will have the ability to discuss the calls which may affect the match.
 - Discussion ensued – decided not to have a fourth official for the Fall tournament.
- Positive feedback was received for the officiating at the U9 level.
- Tourney scheduling – ensure sufficient time is available to start and complete the tourney considering the onset of darkness after daylight savings time.
 - Consider moving the start time after further discussion at the October meeting.
- Positive feedback from the referees – yellow cards are down, no red cards to date
- Concern voiced about a referee leaving after their completed match but not staying for the next match – Bobby will discuss with WMSOA.
- Reschedule requests were discussed.
- Reviewed the referee fee increase for the next 3 year contract – all in attendance approved.
- MSYSA affiliation
 - Three areas use MSYSA as their primary insurance.
 - Based on USSF rule updates, recreational U12 and below matches will not be considered scoring games, only instructional play.
 - Bobby has received quotes from multiple insurance carriers if the league decides not to affiliate.
 - MSYSA is enforcing in-house registration through their organization
 - WMSOA matches would cost more in the event we do not continue our affiliation with USSF
 - October's meeting will include discussions on how we want to move the league forward.
